**SHANNON FRANKE GROUP CHILDCARE HOME SPECIAL LAND USE** - Consider request for Special Land Use approval for a Group Childcare Home as required in Section 11.02(B) and Section 6.02(E) for parcel no. 038 07 0039 000 (7138 Fox Woods Dr.). Property is located north of Hanford Road and east of Canton Center Road (Fox Meadow).

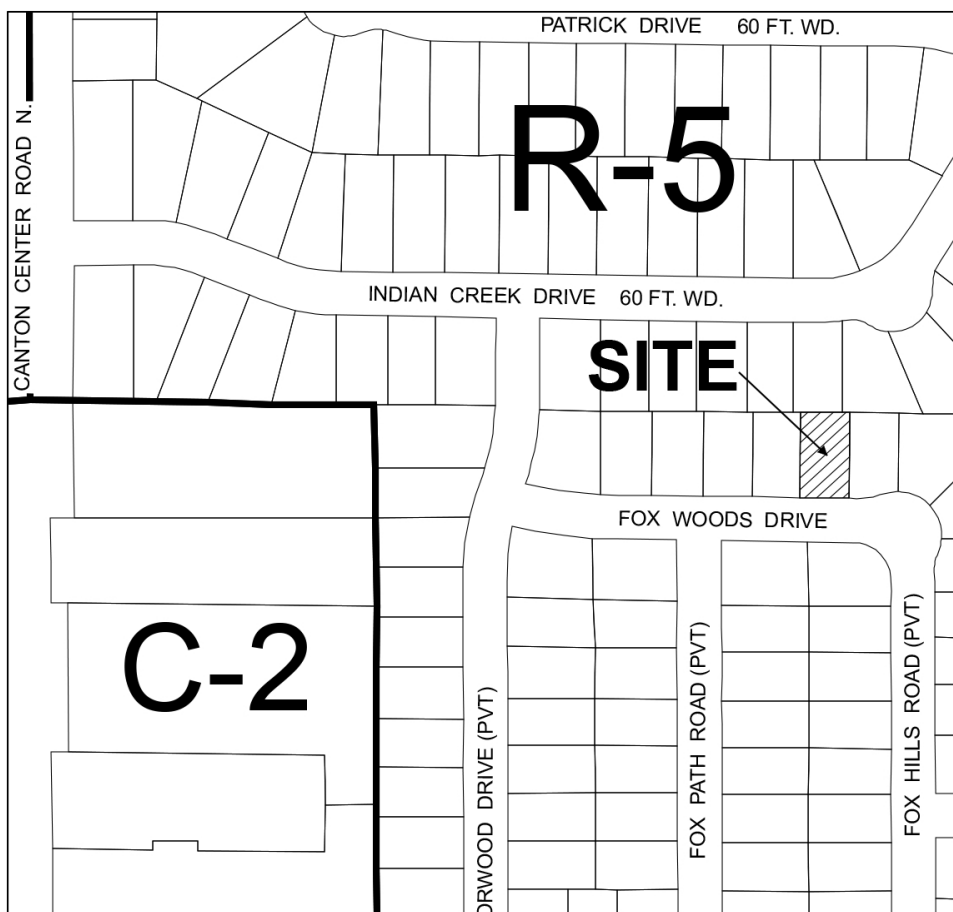
