PROPOSED AMENDMENT TO THE ZONING ORDINANCE OF THE CHARTER TOWNSHIP OF CANTON, WAYNE COUNTY, MICHIGAN.

NOTICE IS HEREBY GIVEN pursuant to Michigan Public Act 110 of 2006, of the State of Michigan, as amended, and pursuant to the Zoning Ordinance of the Charter Township of Canton that the Planning Commission of the Charter Township of Canton will hold a Public Hearing on **Monday, August 2, 2021 at 7:00 p.m.** by electronic remote access on the following proposed amendment to the Canton Township Zoning Ordinance:

RIDGE CREEK PLANNED DEVELOPMENT DISTRICT (PDD) AMENDMENT - Consider request to amend the Planned Development District as permitted in Section 27.04 of the Zoning Ordinance on parcel nos.: 71-025-99-0004-701. Property is located on the south side of Warren Road, west of Ridge Road. Proposed amendments to the Planned Development District include changes to the garage location requirements, entrance signs, and approval period.

To mitigate the spread of the COVID-19 pandemic, protect the public health, and provide essential protections to Canton Township residents; the Canton Township Planning Commission will conduct its meeting on Monday, August 2, 2021 at 7:00 p.m. by video teleconference in accordance with Michigan law.

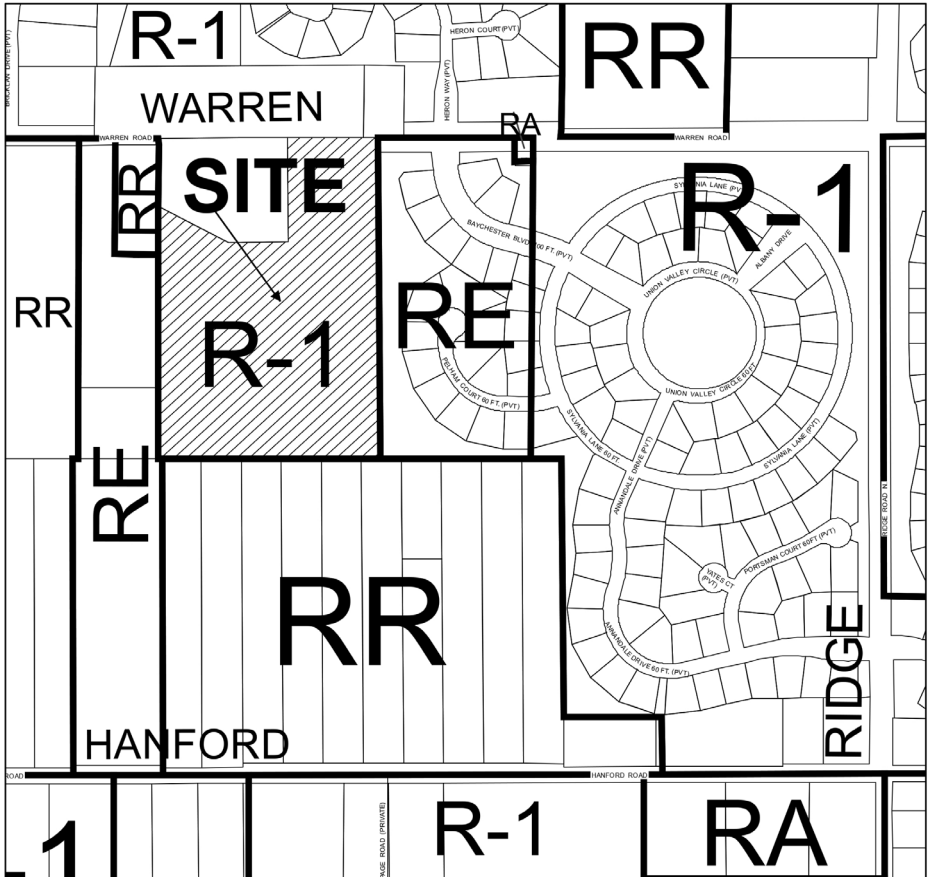
