PROPOSED AMENDMENT TO THE ZONING ORDINANCE OF THE CHARTER TOWNSHIP OF CANTON, WAYNE COUNTY, MICHIGAN.

NOTICE IS HEREBY GIVEN pursuant to Michigan Public Act 110 of 2006, of the State of Michigan, as amended, and pursuant to the Zoning Ordinance of the Charter Township of Canton that the Planning Commission of the Charter Township of Canton will hold a Public Hearing on **Monday, September 13, 2021 at 7:00 p.m.** by electronic remote access on the following proposed amendment to the Canton Township Zoning Ordinance:

**BJ'S WHOLESALE CLUB PLANNED DEVELOPMENT DISTRICT (PDD) AMENDMENT** - Consider request to amend the Planned Development District as permitted in Section 27.04 of the Zoning Ordinance on parcel no.: 71-040-99-0006-709 (43690 Ford Rd.). Property is located on the north side of Ford Rd., between Sheldon Rd. and Morton Taylor Rd. Proposed amendments to the Planned Development District include reducing the number of parking spaces, adding cart corrals, and the establishment of an accessory automobile service station use (Tire Center) for a proposed retail superstore.

To mitigate the spread of the COVID-19 pandemic, protect the public health, and provide essential protections to Canton Township residents; the Canton Township Planning Commission will conduct its meeting on Monday, September 13, 2021 at 7:00 p.m. by video teleconference in accordance with Michigan law.


