NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN pursuant to Michigan Public Act 110 of 2006, of the State of Michigan, as amended, and pursuant to the Zoning Ordinance of the Charter Township of Canton that the Planning Commission of the Charter Township of Canton will hold a Public Hearing on **Monday, November 1, 2021 at 7:00 p.m.** by electronic remote access on the following proposed Special Land Use request as provided in Section 27.03 of the Canton Township Zoning Ordinance:

DOGOLOGY INDOOR PET BOARDING AND TRAINING FACILITY ESTABLISHMENT - Consider request for approval to expand the Special Land Use for an indoor pet boarding and training facility (Section 16.02(B)(10) of the Zoning Ordinance) on parcel no. 71-057-01-0013-301 at 44125 Ford Rd. Property is located on the south side of Ford Road and the east side of Brookline Rd. Property is zoned C-2, Community Commercial District and OSP, Off-Street Parking District, and is within the Central Business District (CBD) Overlay. The Charter Township of Canton is also in the process of considering a separate zoning amendment application to rezone a portion of the subject property from OSP to C-2, which will allow for this Special Land Use request within the proposed C-2 area if approved.

To mitigate the spread of the COVID-19 pandemic, protect the public health, and provide essential protections to Canton Township residents; the Canton Township Planning Commission will conduct its meeting on Monday, November 1, 2021 at 7:00 p.m. by video teleconference in accordance with Michigan law.

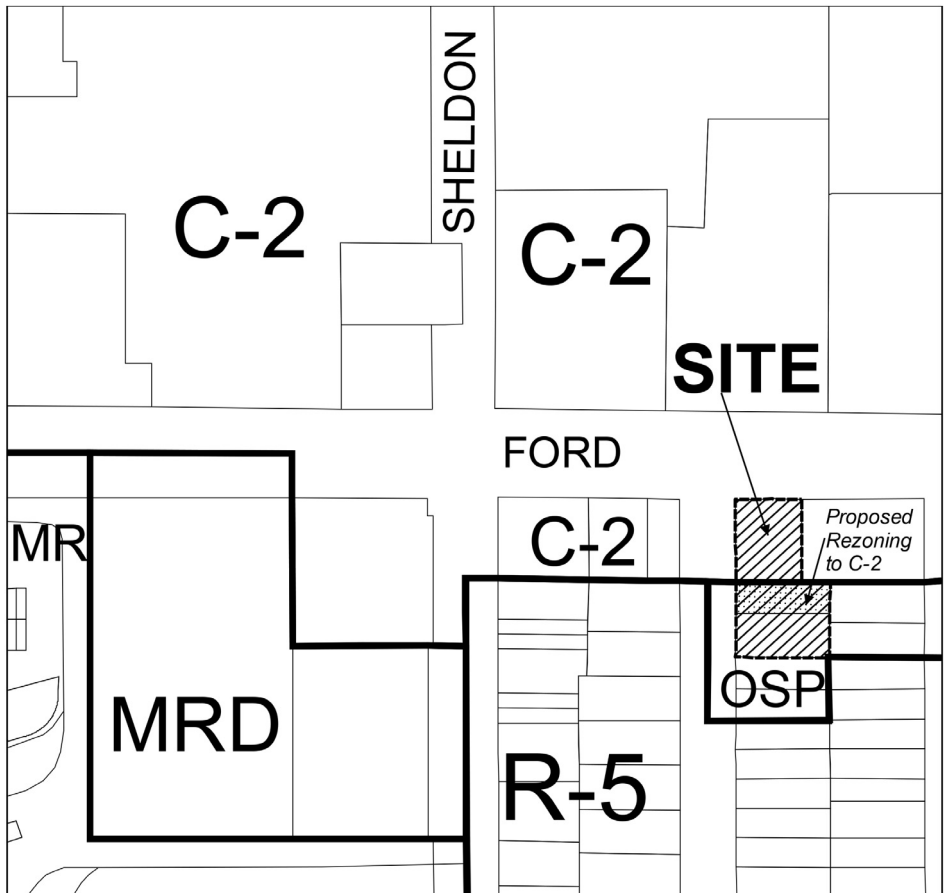
