NOTICE IS HEREBY GIVEN pursuant to Michigan Public Act 110 of 2006, of the State of Michigan, as amended, and pursuant to the Zoning Ordinance of the Charter Township of Canton that the Planning Commission of the Charter Township of Canton will hold a Public Hearing on **Monday, December 6, 2021 at 7:00 p.m.** by electronic remote access on the following proposed Special Land Use request as provided in Section 27.03 of the Canton Township Zoning Ordinance:

CANTON BANQUET AND CONVENTION CENTER - Consider request for Special Land Use approval for a convention center and banquet facility (Section 22.02(B)(6) of the Zoning Ordinance) on parcel no. 141-99-0027-716. Property is zoned LI, Light Industrial District, and located on the east side of Lotz Road and south of Michigan Ave.

To mitigate the spread of the COVID-19 pandemic, protect the public health, and provide essential protections to Canton Township residents; the Canton Township Planning Commission will conduct its meeting on Monday, December 6, 2021 at 7:00 p.m. by video teleconference in accordance with Michigan law.


