#### 4. Chairperson's Report, John Barden, Mayor Pro-Tem

Res. #20-111 Moved by Eva Webb, seconded by Kathy Abdo to concur with the Administration and the Human Resources Director's recommendation to approve the Tentative Agreement for the successor Collective Bargaining Agreement between the City of Romulus and the Teamsters Local 214, to be effective from July 1, 2020 through June 30, 2024. Motion Carried Unanimously.

- Res. #20-112 Moved by Eva Webb, seconded by William Wadsworth to authorize the Mayor A. and Clerk to enter into a Resolution Regarding the Coronavirus (COVID-19) - City to continue the State of Emergency for the City of Romulus until the expiration of the Governor's State of Emergency and any extensions of that State of Emergency by the Legislature. Motion Carried Unanimously.
- **Res. #20-113** Moved by **Kathy Abdo**, seconded by **Tina Talley** to concur with the administra-tion and authorize the Mayor and Clerk to enter into the Construction Services MDOT Tri-party B. Agreement with ROWE Engineering for the Beverly Road Phase I (Middlebelt to Beverly Court) project. The agreement proposal outlines a construction service plan with a cost of \$164,376.04. Note that 80% of this cost will be paid by the State of Michigan. Motion Carried Unanimously.
- C. Res. #20-114 Moved by William Wadsworth, seconded by Celeste Roscoe to concur with the administration and authorize the Mayor and Clerk to enter into the Intergovernmental Agreement and Park Improvement Grant with Wayne County (pending approval by Wayne County Commissioners), accepting the awarded \$24,895.00 grant for improvements to McAnally Park located on 6127 Cordell Street and Jimmy Raspberry Park, located on 36289 Cypress Street to update and reopen these parks. Motion Carried Unanimously.
