NOTICE IS HEREBY GIVEN THAT A SPECIAL ELECTION WILL BE HELD IN THE CITY OF ROMULUS ON **TUESDAY, MAY 4, 2021. THE POLLS WILL BE OPEN FROM 7:00 a.m. to 8:00 p.m.** for the purposes of voting on the following proposal(s):

ROMULUS COMMUNITY SCHOOLS OPERATING MILLAGE PROPOSAL

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Romulus Community Schools, Wayne County, Michigan be renewed by 17.6836 mills (\$17.6836 on each \$1,000 of taxable valuation) for a period of 10 years, 2022 to 2031, inclusive, and also be increased by .5 mill (\$0.50 on each \$1,000 of taxable valuation) for a period of 10 years, 2022-2031, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2022 is approximately \$10,230,000 (this millage is to renew millage that will expire with the 2021 levy and to restore millage lost as a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963 and will be levied only to the extent necessary to restore that reduction)?

Shall Woodhaven-Brownstown School District, Wayne County, Michigan borrow the sum of not to exceed One Hundred Forty-Four Million Dollars (\$144,000,000) and issue its general obligation unlimited tax bonds therefore, in one or more series, for the purposes of: erecting, furnishing and equipping school buildings and structures; erecting, furnishing and equipping additions to school buildings; remodeling, equipping and re-equipping and furnishing and refurbishing school buildings; acquiring, installing equipping and re-equipping school buildings for instructional technology; purchasing school buses; and preparing, equipping, developing and improving play grounds athletic fields and facilities and sites?


