- A resident thanked the mayor and council for the improved roads in her subdivision and raised concerns about the condition of Hyde Park after DTE's gas work, noting that yards were left bumpy and only grass seed was put down. - A representative of Waste Management thanked the community, especially Director Scappaticci and the Solid Waste Committee, for their hard work in the contract process. She expressed gratitude for the opportunity to continue serving the community for another 10 years and presented a WM die-cast truck as a token of appreciation.
