CHAPTER 46, SECTION 46-2; TO PROVIDE THAT A VIOLATION OF THE ORDINANCE IS PUNISHABLE BY IMPRIS ONMENT FOR NOT MORE THAN 93 DAYS OR A FINE OF NOT MORE THAN \$500.00. OR BOTH, IF THE VIOLATION SUBSTANTIALLY CORRESPONDS TO A VIOLATION OF A STATE LAW THAT IS A MISDEMEANOR FOR WHICH THE MAXIMUM PERIOD OF IMPRISONMENT IS 93 DAYS; TO PROVIDE FOR REPEAL OF CONFLICTING ORDINANCES, SEVERABILITY, AND SAVING OF ALL PENDING MATTERS; AND TO PROVIDE FOR PUBLICATION AND THE EFFECTIVE DATE. THE CHARTER TOWNSHIP OF CANTON ORDAINS: SECTION 1: AMENDMENT TO CHAP-TER 1, SECTION 1-7(c) AND CHAPTER 46, SECTION 46-2 OF THE CANTON TOWNSHIP CODE OF ORDINANCES This section provides that Chapter 1, Section 1-7(c) and Chapter 46, Section 46-2 is amended to read that the general penalty for a violation of an ordinance is up to \$500.00 and/or 90 days imprisonment plus court costs, but for an ordinance that substantially corresponds to a violation of state law for which the maximum period of imprisonment is 93 days, the penalty for violation of such ordinance is up to \$500.00 and/or 93 days imprisonment plus court costs. It also specifically lists the current ordinance provisions that have such corresponding state law 93 day offenses. SECTION 2. REPEAL. This section provides that all Ordinances or parts of Ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect. SECTION 3. SEVERABILITY. This section provides that any unenforceable section can be severed from the rest of the Ordinance. SECTION 4. SAVINGS CLAUSE. This section provides that adoption of this Ordinance does not affect proceedings, prosecutions for violation of law, penalties and matured rights and duties in effect before the effective date of this Ordinance. SECTION 5. PUBLICATION. This section provides that the Clerk shall cause this Ordinance to be published. SECTION 6. EFFECTIVE DATE. This section provides that this Ordinance shall take full force and effect upon publication.
