Supervisor LaJov stated as a state and nation this has had an extremely difficult year. 7% of Canton residents tax bill actually goes to Canton Township. 27% of the 7% is the General Fund, 27% is Fire and 46% goes to Police. 73% of the tax revenue received by Canton goes to Public Safety, Police and Fire. Supervisor LaJoy stated Canton has three separate distinctive funds: General Fund. Police Fund and Fire Fund. Public Safety is extremely dependent on the taxable value revenue. The General Fund not quite as dependent as there are other sources of revenue. Police receives approximately 97% of the revenue from the tax dollars and Fire receives approximately 80% Fire receives revenue from ambulance transports and insurance. There has been a traumatic decline in taxable value of homes since 2007. This decline could never have been imagined. Five residents spoke in favor of the millage increase and one in opposition of the millage increase.
