A regular meeting of the Board of Trustees of the Charter Township of Canton was held Tuesday, October 12, 2010 at 1150 Canton Center S., Canton, Michigan. **Adoption of Agenda** Motion by Bennett, supported by Anthony to approve the agenda as amended adding G-3 Consider Approval of Amended Wastewater Disposal Agreement with Sauk Trail Development, Inc. Motion carried by all members present. **Approval of Minutes** Motion by Bennett, supported by Taj to approve the Board Study Meeting Minutes of September 23, 2010. Motion carried by all members present. Motion by Bennett, supported by Williams to approve the Board Meeting Minutes of September 28, 2010. Motion carried by all members present. **Citizen's Non-Agenda Item Comments:** Clare Barwick, 6662 Weatherfield Way, stated she wished to thank the Board and Public Safety for their commitment to the Canton residents. Ms. Barwick stated she understood there was a hiring freeze, yet the positions are being filled. She asked for an explanation. Motion carried by all members present. **CONSENT CALENDAR: Item 1. REQUEST FOR RESOLUTION OF LOCAL BODY OF GOVERNMENT TO RECOGNIZE "PLYMOUTH CANTON YOUTH SPORTS, INC." (PCYS) AS A NONPROFIT IN THE COMMUNITY FOR PURPOSES OF MAKING APPLICATION FOR A "CHARITABLE GAMING LICENSE" TO THE BUREAU OF STATE LOTTERY.** (CLERK) Motion by Bennett, supported by McLaughlin to approve the request from the "Plymouth Canton Youth Sports, Inc.", 32000 Northwestern Hwy., Ste. 260, Farmington Hills, Michigan 48334 (Office of Resident Agent), to be recognized as an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code for the purpose of obtaining a charitable gaming license. Motion carried by all members present. **RESOLUTION OF BOARD OF TRUSTEES, CHARTER TOWNSHIP OF CANTON Zoning Ordinance Amendment – Temporary Banner Regulations WHEREAS,** the Township is desirous of amending Article 6A, of Appendix A – Zoning of the Code of Ordinances of the Charter Township of Canton as provided on Attachment A.; and, **WHEREAS,** the Planning Commission held a public hearing on September 13, 2010 and voted 3-3 not to recommend approval of the amendments based on the findings that changes are not consistent with the development objectives of the community; and, **WHEREAS,** the Board has reviewed the proposed amendment and have reviewed the planning Commission discussion and have considered of the Planning Commission recommendation. **NOW THEREFORE BE IT RESOLVED,** the Board of Trustees of the Charter Township of Canton, Michigan does hereby approve the proposed amendments to Article 6A of Appendix A Zoning, of the Code of ordinances of the Charter Township of Canton as provided in Attachment A.

### ATTACHMENT A – Zoning Ordinance Amendment for Temporary Banners 6A.15. Signs permitted in all commercial and industrial districts.

NA	- May be displayed for a total period of up to <u>four eighteen</u> weeks within the calendar year that the first permit was applied for - <del>Three</del> <u>Six</u> permits may be issued per calendar year. <u>Each permit shall allow banners or temporary signs to be displayed for up to but not exceeding three weeks.</u> - Such signs must be attached to the building.
