PUBLICATION AND EFFECTIVE DATE. THE CHARTER TOWNSHIP OF CANTON ORDAINS: SECTION 1 ORDINANCE Section 46-416 Division 3, Article VI, Offenses Involving Public Morals is hereby added to read as follows: Sec. 46-416. - Exceptions. Gaming licensed and regulated by Public Act No. 382 of 1972 (MCL 432.101 et sea.) Is exempt from the provisions of this article. SECTION 2 SEVERABILITY If any clause, sentence, section, paragraph or part of this Ordinance, or the application of thereof to any person. firm, corporation, legal entity or circumstances, shall be for any reason adjudged by a court of competent jurisdiction to be unconstitutional or invalid, said judgment shall not affect, impair or invalid the remainder of this Ordinance. It is hereby declared to the legislative intent of this body that the Ordinance is severable, and that the Ordinance would have been adopted had such invalid or unconstitutional provisions not have been included in this ordinance. SECTION 3 SAVINGS CLAUSE All rights and duties which have matured penalties which have been incurred, proceedings which have begun and prosecution for violations of law occurring before the effective date of this Ordinance are not affected or abated by this Ordinance. SECTION 4 PUBLICATION The Clerk for the Charter Township of Canton shall cause this Ordinance to be published in the manner required by law. SECTION 5 EFFECTIVE DATE This Ordinance shall take full force and effect upon publication as required by law. Item 5. APPROVE REVISIONS TO THE CANTON BOARD OF REVIEW GUIDELINES FOR HARDSHIP APPEALS. NOW THEREFORE BE IT RESOLVED, the Board of Trustees of the Charter Township of Canton, Michigan does hereby approve the proposed amendments to Section 17.02B of Appendix A- Zoning, of the Code of ordinances of the Charter Township of Canton as provided in Attachment A. ATTACHMENT A -Zoning Ordinance Amendment 2011-1 Article 17.00 C-3, REGIONAL COMMERCIAL DISTRICT 17.02. Permitted Uses and Structures B. Special Land Uses. 13a. Automobile filling stations (limited to redevelopment of existing stations or stations which are accessory to primary retail uses or individual tenants within a shopping center, having a gross floor area over 50,000 square feet), subject to the provisions in Section 6.02 C. A zoning ordinance regulating the development and use of land has been adopted by the legislative body of the Township of Canton. In accordance with Public Act 110 of 2006 the zoning ordinance shall take effect March 10, 2011.
